KATEGORIEBEPALINGS

"Sakeman van die Jaar" is van toepassing op manlike sakeleiers.

"Sakevrou van die Jaar" is van toepassing op vroulike sakeleiers.

MOTIVERING

BEOORDELINGSPROSES

BEKENDMAKING

Finaliste sal voor die jaareindfunksie aangekondig word.

TERMS AND CONDITIONS FOR NOMINATIONS

VALIDITY OF NOMINATIONS

Nominations must be submitted on the official application form before the closing date, 23 October 2026. Incomplete or late submissions will not be considered.

WHO MAY NOMINATE

Any member of the community or business community may submit a nomination. Self-nominations are permitted.

WHO MAY BE NOMINATED

Nominees must be a natural person and an active role player in the Durbanville business community. He/she does not have to be a member of the Durbanville Business. Nominees must have a good reputation and uphold ethical business practices. If the nominee is one of the top candidates, he/she **MUST** be able to attend the function.

CATEGORY CRITERIA

"Businessman of the Year" applies to male entrepreneurs or business leaders.

"Businesswoman of the Year" applies to female entrepreneurs or business leaders.

MOTIVATION

A clear written motivation must be provided, highlighting the nominee's contributions and achievements.

JUDGING PROCESS

The final decision will be made by the Durbanville Business Chamber 2025/2026 committee. No correspondence will be entered into regarding the panel's final decision.

TRANSPARENCY

The Chamber reserves the right to request additional information from the nominee or nominator. False or misleading information may result in disqualification.

ANNOUNCEMENT

Finalists will be announced before the year-end function.

The winner in each category will be announced during the Durbanville Business Chamber's year-end function.
